AN ORDINANCE TO CONDEMN AN UNSAFE AND DANGEROUS BUILDING AT NORTH WILSON STREET, OBLONG, ILLINOIS

BE IT ORDAINED by the Board of Trustees of the Village of Oblong,
Crawford County, Illinois, that it has determined that the building situated upon the
premises at 313 North Wilson Street, Oblong, Illinois, and more particularly
described as follows, to-wit-it is hereby amended such that it shall be, in its
entirety, as follows:

Lots Twenty-five (25) and Twenty-six (26) in Lucy F. Meyer's Addition to the Village of Oblong, Illinois, situated in the East part of the Northeast Quarter of the Southeast Quarter of Section Thirty-six (36) in Town Seven (7) North, Range Fourteen (14) West, Crawford County, Illinois.

is unsafe and dangerous and should be either put in a safe condition or demolished; and accordingly, said building located at 313 North Wilson Street, Oblong, Crawford County, Illinois is hereby declared to be unsafe and dangerous and is condemned, all pursuant to Illinois Compiled Statutes, being 65 ILCS 5/11-31-1, et seq.

BE IT FURTHER ORDAINED that the Village attorney be directed to commence proceedings under the Unsafe Property Act, as provided for under the laws of the State of Illinois, and to give 30 days' written notice by mail to said

owners and occupiers to either place said building in a safe condition or to
demolish it and to follow the other procedures as provided by law.
